NOTICE OF CLASS ACTION SETTLEMENT

Read this notice carefully. Your legal rights could be affected whether you act or do not act. You are eligible for a payment from a class action settlement relating to System Transport, Inc.'s, T-W Transport, Inc.'s and Bulk Service Transport, Inc.'s hiring practices.

To receive your settlement payment, you must submit a valid and timely Claim Form and not exclude yourself from the Settlement as explained below.

A Washington State Superior Court authorized this Notice. You are <u>not</u> being sued. This is <u>not</u> a solicitation from an attorney.

• Applicants for employment, Carl Schenk and Malik Wallace ("Plaintiffs" or "Class Representatives"), filed a lawsuit against System Transport, Inc., T-W Transport, Inc., and Bulk Service Transport, Inc. d/b/a James J. Williams Bulk Service Transport ("Defendants," and together with Plaintiffs, the "Parties") on behalf of themselves and a putative class of applicants. The lawsuit, *Schenk, et al. v. System Transport, Inc., et al.*, Case No. 24-2-01352-1 SEA (the "Lawsuit") is currently pending in King County Superior Court. Plaintiffs claim in the Lawsuit that Defendants' job postings for open positions in Washington did not disclose the wage scale or salary range being offered in violation of Washington law. Defendants dispute Plaintiffs' claims and contend they have not violated any law and Plaintiffs' claims are without merit.

• The Court has not made any determinations regarding the merit or lack of merit of the Plaintiffs' claims or who will prevail in the Lawsuit, and it has not decided whether Defendants' actions were lawful or violated the law.

• The Parties to the Lawsuit have reached a proposed Class Action Settlement. The Proposed Class Action Settlement includes a minimum payment of \$1,000,000 ("Minimum Settlement Fund") and a maximum payment of \$1,438,500 ("Maximum Settlement Fund") by Defendants' insurance company (Travelers Insurance Companies) depending on the number of valid and timely claims submitted. On March 28, 2025, the Court issued an order preliminarily approving the Settlement and authorizing the Settlement Administrator CPT Group, Inc. ("Settlement Administrator") to issue this Notice and Claim Form.

• You are receiving this Notice because Defendants' records indicate you may be eligible to participate in the proposed Class Action Settlement as a member of the Settlement Class. "Settlement Class Members" include "Plaintiffs and all individuals who, from January 1, 2023 through December 31, 2024 (the "Settlement Class Period"), applied for a job opening in the State of Washington with Defendants System Transport, Inc., T-W Transport, Inc., and/or Bulk Service Transport, Inc. d/b/a James J. Williams Bulk Service Transport, where the job posting did not disclose the wage scale or salary range and/or a general description of benefits or other compensation for the position." If the Settlement receives final approval and the judgment becomes final, you are eligible for a payment between \$1,169.33 and \$5,000.00 but only if you do not opt out of the settlement and submit a valid and timely Claim Form via the mail or through the online claims process. Specifically, to receive your settlement payment, you must either, (1) complete the enclosed Claim Form and return it by mail; or (2) submit your claim online at: www.SystemTransportAction.com by July 11, 2025.

• The Court still has to decide whether to finally approve the Settlement. No settlement benefits or payments will be provided unless the Court approves the Settlement, and it becomes completely final.

BASIC INFORMATION

1. What is this Notice and why should I read it?

The Court authorized this Notice to inform you about a proposed class action settlement with Defendants. You have legal rights and options that you may act on before the Court decides whether to approve the proposed Settlement. If the settlement is finally approved and the judgment becomes final, you are eligible to receive a cash payment as part of the Settlement as long as you submit a valid and timely claim. This Notice explains the Lawsuit, the Class Action Settlement Agreement ("Settlement Agreement"), and your legal rights.

Judge Elizabeth Berns of King County Superior Court is overseeing this putative class action Lawsuit. The case (or Lawsuit) is titled *Schenk, et al. v. System Transport, Inc., et al.* Case No. 24-2-01352-1 SEA.

Carl Schenk and Malik Wallace are the Plaintiffs and Class Representatives. The companies they sued, System Transport, Inc., T-W Transport, Inc., and Bulk Service Transport, Inc., are the Defendants.

2. What is a class action lawsuit?

A class action is a lawsuit in which one or more plaintiffs sue on behalf of a group of people who assert they have similar claims. Together, this group is called a "Settlement Class" and consists of "Settlement Class Members." In a class action, the court resolves the issues for all class members, except those who exclude themselves from the class.

3. What is this lawsuit about?

Plaintiffs claim that Defendants violated Washington law, RCW 49.58.110, by not disclosing the wage scale or salary range being offered in job postings for open positions.

Defendants deny all of the claims in the Lawsuit and contend that they are not liable to Plaintiffs or the Settlement Class in any way. More information about the Lawsuit can be found in the "Court Documents" section of the Settlement Website at www.SystemTransportAction.com.

4. Why is there a settlement?

The Court has not decided whether the Plaintiffs or Defendants should win this case. Instead, both sides agreed to this Settlement. That way, they can avoid the uncertainty, risks, and expense of ongoing litigation, and Settlement Class Members can get compensation now rather than years later—if ever. The Plaintiffs and Class Counsel, attorneys for the Settlement Class Members, agree the Settlement is in the best interests of the Settlement Class Members. The Settlement is not an admission of wrongdoing by Defendants or any of the other Released Parties.

5. How do I know if I am in the Settlement Class?

Defendants' records show you are part of the Settlement Class because you applied for a job opening in Washington with Defendants between January 1, 2023 and December 31, 2024 (the "Settlement Class Period") where the job posting allegedly did not disclose the wage scale or salary range and/or a general description of benefits or other compensation for the position. If you are still not sure whether you are included, you can contact the Settlement Administrator by calling tollfree at **1-888-497-9714**, emailing **SystemTransportAction@cptgroup.com**, or by visiting the Settlement Website at www.SystemTransportAction.com.

THE SETTLEMENT BENEFITS

6. What does the settlement provide?

All Settlement Class Members who submit a timely, valid Claim Form, either by mail or through the online claims submission process on the settlement website, are eligible to receive an equal share of the Settlement Fund. Your estimated payment amount is \$1,169.39, but it could be as high as \$5,000.00 depending on how many Settlement Class Members submit a valid and timely Claim Form.

Settlement payments will be characterized as non-wage damages and interest and reported on a Form1099-Misc.

7. How do I receive a payment?

To qualify for a settlement payment, you must do one of two things.

First, you can choose to complete the enclosed Claim Form and submit it by mail, <u>postmarked on or before</u> July 11, 2025, to:

Alternatively, you may submit a claim online on the official settlement website, www.SystemTransportAction.com using Unique ID, CPT ID: <<ID>> and Passcode: <<Passcode>>. If you choose to submit a claim on the settlement website, you must submit your claim on or before July 11, 2025.

Claims will be subject to a verification process. <u>All mailed Claim Forms and submissions online must be</u> postmarked or submitted on or before July 11, 2025.

To ensure you receive your payment, you <u>must</u> contact the Settlement Administrator if your address or phone

number changes at any time. The Settlement Administrator may be contacted at:

8. When will I get my payments?

The hearing to consider the fairness of the Settlement is scheduled for **September 12 at 1:00 P.M.** If the Court approves the Settlement, eligible Settlement Class Members who submitted a timely, valid Claim Form either by mail or online through the settlement website will be mailed a check after the Settlement becomes completely final. Please be patient. All checks will expire and become void 180 days after the date of issuance.

9. Will Defendants retaliate against me if I participate in the Settlement?

No. Defendants support the Settlement and will not retaliate in any way against any Settlement Class Member for participating in the Settlement. Your decision to participate, not participate, or object to the Settlement will not affect any application for employment with Defendants or Defendants' treatment of you as a current or former employee.

THE ATTORNEYS REPRESENTING YOU

10. Do I have an attorney in this case?

Yes, the Court appointed Craig J. Ackermann, Avi Kreitenberg, and Brian Denlinger of Ackermann & Tilajef, P.C. as Class Counsel to represent the Settlement Class. Their contact information is:

Should I get my own attorney? You don't need to hire your own attorney because Class Counsel are working on your behalf. These attorneys and their firm are experienced in handling similar cases. You will not be charged for these attorneys. You can ask your own attorney to appear in Court for you, at your own cost, if you want someone other than Class Counsel to represent you.

11. How will Class Counsel and the Class Representatives be paid?

Class Counsel will ask the Court to approve, and Defendants agree not to oppose, an award of attorneys' fees in the amount up to \$431,550 and litigation costs in the amount up to \$10,000, to be paid from the Settlement Fund. Class Counsel will also request a service award for each of the Plaintiffs in the amount of \$10,000, to be paid from the Settlement Fund. The Court will determine the proper amount of any attorneys' fees, costs, and expenses to award Class Counsel and the proper amount of any service award to Plaintiffs. The Court may award less than the amounts requested. Whether the Settlement will be finally approved does not depend on whether or how much the Court awards in attorneys' fees, costs, and expenses or service awards.

YOUR RIGHTS AND OPTIONS

12. What claims do I give up by participating in this Settlement?

If the Court approves the Settlement, the Court will enter a final judgment dismissing the Lawsuit "with prejudice." This means that the claims in the Lawsuit will be permanently dismissed. Specifically, Defendants will be "released" from claims as described in Paragraph 18 of the Settlement Agreement, which states that upon final approval of this Settlement Agreement by the Court, each Settlement Class Member who does not submit a valid and timely request for exclusion:

will release the Released Parties from any and all claims that arose during the settlement class period (i.e., from January 1, 2023 through December 31, 2024) that were asserted or could have been asserted against the Defendants or the other Released Parties by members of the Settlement Class based on the claims, allegations, facts, events, omissions, or occurrences asserted in the First Amended Complaint filed in the Lawsuit or claims that could have been asserted based on the allegations, facts, events, omissions, or occurrences alleged in the First Amended Complaint (the "Released Class Claims"). The Released Class Claims shall include, but not be limited to, any claims based on Defendants and the other Released Parties' alleged failure to comply with the job posting/pay transparency requirements of the Washington Equal Pay and Opportunities Act, including, but not limited to, any alleged liabilities arising out of or relating to a failure to include the wage scale or salary range, a general description of all of the benefits, and/or other compensation to be offered to a hired applicant in any job postings. The Released Class Claims also specifically include, but are not limited to, any claims arising out of or relating to a violation of RCW 49.58.110, and any attendant claims for relief under RCW 49.58.070, interest, liquidated damages, exemplary damages, statutory damages, minimum statutory damages, and attorneys' fees and costs relating to any of the foregoing. All Settlement Class members further agree that they cannot sue or seek recovery against Defendants or other Released Parties for any Released Class Claims.

The Released Parties are Defendants, together with each of their direct and indirect parents, subsidiaries, affiliates, divisions, related companies/corporations and/or partnerships, and each of their respective past and present directors, officers, agents, shareholders, members, managers, employees, attorneys, insurers (including Travelers Insurance Companies), successors, and assigns.

By being part of the Settlement, Settlement Class Members agree that they cannot sue or seek recovery against Defendants or other Released Parties as described in the Settlement Agreement for any Released Class Claims. Participating in the Settlement does not, however, waive claims outside the release.

Any potential Settlement Class Member who does not request exclusion by the applicable deadline will be a Settlement Class Member and will be considered to have accepted the above release and to have waived any and all of the Released Class Claims against the Released Parties. Any potential Settlement Class Member who requests exclusion by the applicable deadline is not a Settlement Class Member, will not be subject to the release, and will not receive any payment.

13. What happens if I do nothing?

If you do nothing, you will receive no payment under the Settlement. You will still be in the Settlement Class, and, if the Court approves the Settlement and the judgment becomes final, you will be bound by all orders and judgments of the Court, the Settlement Agreement, and its included release. You will be deemed to have participated in the Settlement and will be subject to the provisions of Section 12 above. Unless you exclude yourself, you won't be able to file a lawsuit or be part of any other lawsuit against Defendants for the claims or legal issues resolved in this Settlement.

14. What happens if I request to be excluded?

If you submit a timely, valid request for exclusion from the Settlement, you will receive no benefits or payment under the Settlement. However, you will not be in the Settlement Class, will not release claims against Defendant, and will not be legally bound by the Court's judgments in this Lawsuit.

15. How do I request to be excluded?

To request to be excluded from the Settlement, you must send a letter, postmarked no later than July 11, 2025, to the Settlement Administrator at the following address:

To be considered valid, a request for exclusion **must** include: (i) your full name; (ii) your address; (iii) a statement that you wish to be excluded from the settlement (for example, "I request to be excluded from the class action settlement in *Schenk, et al v. System Transport, Inc., et al.* Case No. 24-2-01352-1 SEA"); and (iv) your or your attorney's signature and date signed.

You cannot exclude yourself by phone or email. Each individual who wants to be excluded from the Settlement must submit his or her own request for exclusion. Group requests for exclusion are not permitted.

16. If I don't exclude myself, can I sue Defendants for the same thing later?

No. Unless you exclude yourself, you give up any right to sue Defendants for the claims being resolved by this Settlement even if you do nothing.

17. If I exclude myself, can I get anything from this Settlement?

No. If you exclude yourself, you cannot participate in the Settlement in any way. If you choose to exclude yourself from the Settlement, please do not submit a Claim Form to ask for a payment as it will not be recognized or honored.

18. How do I object to the Settlement?

If you do not exclude yourself from the Settlement Class, you can object to the Settlement if you disagree with any part of it. You can give reasons why you think the Court should deny approval of the Settlement by filing an objection. To object, you must file written notice with the Court stating that you object to the settlement in *Schenk, et al. v. System Transport, Inc., et al.* Case No. 24-2-01352-1 SEA, no later than **July 11, 2025**. Your objection must be filed with the Court, which you can do by mailing your objection and any supporting documents to King County Superior Court at the following address:

If you are represented by an attorney, the attorney may file your objection through the Court's e-filing system.

To be valid, your objection must be in writing and include: (i) your full name, address, telephone number, and email address; (ii) the case name and number; (iii) the reasons why you object to the Settlement; (iv) the name and address of your attorney, if you have retained one; (v) a statement confirming whether you and/or your attorney intend to personally appear at the Final Approval Hearing; (vi) a list, by case name, court, and docket number, of all other cases in which you (directly or through an attorney) have filed an objection to any proposed class action settlement within the last three years; (vii) a list, by case name, court, and docket number, of all other cases in which your attorney intend to any proposed class action settlement within the last three years; (vii) a list, by case name, court, and docket number, of all other cases in which your attorney (on behalf of any person or entity) has filed an objection to any proposed class action settlement within the last three years; and (viii) your or your attorney's signature and date signed.

In addition to filing your objection with the Court, you must also mail copies of your objection and any supporting

documents to the Settlement Administrator (*Schenk v. System Transport, Inc.*, c/o CPT Group, Inc., 50 Corporate Park, Irvine, CA 92606 and both Class Counsel and Defendants' attorneys at the addresses listed below, postmarked no later than **July 11, 2025**:

19. What's the difference between objecting and excluding myself from the Settlement?

Objecting simply means telling the Court that you don't like something about the Settlement. You can object only if you stay in the Settlement Class. Excluding yourself from the Settlement Class is telling the Court that you don't want to be part of the Settlement Class. If you exclude yourself, you have no basis to object because the case no longer affects you.

THE COURT'S FINAL APPROVAL HEARING

20. When and where will the Court hold a hearing on the fairness of the Settlement?

The Court will hold the Final Approval Hearing on **September 12 at 1:00 P.M.** in King County Superior Court, 516 3rd Ave., Seattle, Washington 98104.

The purpose of the hearing is for the Court to determine whether the settlement is fair, reasonable, adequate, and in the best interests of the Settlement Class. At the hearing, the Court will hear any objections and arguments concerning the fairness of the proposed Settlement, including those related to the amount requested by Class Counsel for attorneys' fees, costs, and expenses and the service awards for Plaintiffs.

Note: The date and time of the Final Approval Hearing are subject to change by court order. Any changes will be posted at the Settlement Website, **www.SystemTransportAction.com**, or through the Court's publicly available docket. You should check the Settlement Website to confirm the date and time have not been changed if you would like to appear at the Final Approval Hearing.

21. Do I have to come to the hearing?

No. Class Counsel will answer any questions the Court may have, but you are welcome to attend the hearing at your own expense. If you send an objection, you don't have to come to the hearing to talk about it. As long as your written objection was filed or mailed on time and meets the other criteria described above and in the Settlement, the Court will consider it. You may also hire an attorney to attend on your behalf at your own expense, but you don't have to.

22. May I speak at the hearing?

Yes. If you do not exclude yourself from the Settlement Class, you may ask the Court for permission to speak at the Final Approval Hearing concerning any part of the proposed settlement.
